

FORMULATION OF SCHOOL FEES AND FEES POLICY

FEES STRUCTURE FORMULATION

Techno India Group Public School, Ariadaha aims to impart quality education to all classes of the society with high academic standard where Fees Structure is almost accessible to all economic demographical sections.

TIGPS, Ariadaha formulate fees strictly according to CBSE Affiliation Bye-Laws. Fees Structure for 20-21 Academic Session Formulated as per clause 7.1 to 7.3.

TIGPS, Ariadaha always endeavours to charge fees (Admission or other fees) to the extent the expenses for running the school are met in accordance with the Regulation of Govt. Of West Bengal and as prescribed by Department Of Education from time to time and utilizes entire fees collected from the students for school development programme of TIGPS, Ariadaha only and transparent in process of fees related policy and formulation.

Revision :

Fees Revision is being done as per provision of Affiliation Bye-laws vide clause 7.5.2 of New Affiliation Bye-Laws -2018.

The school reserves the right to revise the progressive fee applicable to new admissions every academic year which is carried on with the consent of PTA under the regulation of Govt Of West Bengal and with express approval of the School Managing Committee (SMC).

FEES POLICY

For new admission : Payment made towards the Application Form and its processing is non-refundable and does not guarantee applicants admission.

Fees need to be paid within ten working days from the date of receipt of Admission Acceptance Letter according to the fee payment schedule as notified.

For next session (after promotion to a new class) : Recurring annual fee and tuition fee need to be paid by the first week April. Any payments thereafter would attract late payment charges.

The monthly tuition fees does not include:

Educational excursions, participation in student's exchange programme, representing school at National/International student's workshop/youth science forums, educational excursion, CBSE Board Examination and registration Fees and expenses accrued while preparing or appearing of domestic and international competitive examinations, participation in special school events and any expense borne towards their participation including the costumes, jewellery and props, note books and text books, school uniform, ID cards and badge, monogram etc.

WITHDRAWAL AND REFUND

For refund of fees, in accordance to Clause 7.4, when student is willing to discontinue the studies in the school, dues are collected up to the date till the student discontinued with an intimation to the school are considered, No admission fees which is considered as one time deposit are refunded for existing students and also for the new admitted students.

For the existing students :

Parents will be liable to pay the full fees for the next academic year, if application of withdrawal is not duly submitted to the Principal in writing, by 7th March in the last Academic year or withdrawal at any time after the commencement of the academic year at Techno India Group Public School, Ariadaha.

'Refundable interest free security deposit' which is also considered as one time deposit is refunded without interest in the specified time i.e on completion of student's studies as decided by school managing committee.

Any dues payable to school or any damage caused before leaving the school will be adjusted against the security deposit.

School Leaving certificate (Transfer Certificate) will be issued only after clearance of dues and payment of amount(s) in favour of the school and on return of library books. The school leaving certificate will not be issued during vacations.

In case of students studying in grade 10, if they do not wish to continue in the Class XII a notice of withdrawal has to be given before 31st January of the academic year, failing which full fees (of the following academic year) shall have to be paid to get a clearance for the Transfer/leaving certificate.

Withdrawal against new admission: The fees (Admission fee and others) paid to the school are neither refundable nor transferrable under any circumstances.

Only intimation in writing within 30 days from the date of admission but not after the date of commencement of the class with all relevant documents acceptable to the management or managing committee will be considered for refund of the security fee only and strictly not any other fee. Otherwise any withdrawal without any written intimation to the school authority after the specified stipulated period, no security deposit will be refunded.

Failure to pay any amount due to the school by the representative due dates will imply that the parents do not intend to pursue admission with the school.

Penalties : Vandalism Penalties will be applicable in-case of any damage caused/ dues occurred because of: mishandling or losing of School Library Books and Laboratory Equipments, damaging of school IT facilities, third party damage/ loss caused by the student at the time of events, mishandling or damaging the assets of school and transportation.

Students are allowed to attend classes, participate in activities and have uninterrupted access to school facilities, provided all amounts payable to the school have been duly paid by the due dates.

Inter school Transfer : In case of Inter School Transfer, transaction of security deposit is carried on with the decision of managing committee i.e,

Either the amount deposited as Security Deposit at the time of seeking admissions would be transferred to the destination unit OR it may be refunded to the parent in form of demand draft or banker's cheque and it has to be resubmitted by the parent to the destination unit.

The rules and regulations formulated by Techno India Group Public School, Ariadaha construe for smooth and effective functioning of the school. The school reserves all rights to amend the fee structure and set regulations when needed.
